



## **PUMA X NCT 217 Polaroid Photo Contest Terms & Conditions**

**1. PUMA X NCT 217 Polaroid Photo Contest (hereafter, “the contest”) is organized by PT PUMA CAT INDONESIA (PUMA Indonesia). It begins on 13th September 2023 and ends on 23rd September 2023 (hereafter, “contest period”).**

### **2. Entry Eligibility**

- A. This contest is open to Indonesian residents aged 17 and above.
- B. Permanent and/or temporary staff or employees of PUMA Indonesia including its affiliated and/or related companies, distributors, dealers, advertising and promotions agencies are not eligible to participate in this contest.
- C. PUMA Indonesia reserves the rights to exclude and/or disqualify participants who are in breach of the Contest Terms and Conditions.

- E. All submissions will receive a unique code after data completion. No product exchanges are allowed after the participants have received the unique code.
- F. Participants must contact PUMA Indonesia before 24th September 2023 regarding any issues with submission. PUMA Indonesia will not entertain any claims made after the date.
- G. Registrations made under any unauthorized retailers, as well as registrations on behalf of the participants, will be rejected.

### **3. Contest Details & Mechanics**

- A. The participant who purchases PUMA Army Trainer in a single receipt with our participating authorized retailers between 13th September 2023 and 23rd September 2023 will earn ONE (1) entry to participate in the lucky draw. One receipt should be equivalent with one user identity. Scan the QR code or log in to <http://puma-nct127raffle.com/> to enter.
- B. Complete the online form by filling in all the empty fields and click on submit.
- C. All submitted data should use the same name & identity, any discrepancy will be disqualified.
- D. Retain original single receipt dated within contest period that matches the online entry as proof of purchase.
- E. Only original and valid printed receipts will be accepted. Receipts that are illegible, mutilated, altered, duplicated, tampered with, not obtained legitimately, contain printing typographical, mechanical, or other errors, or have unclear or missing required information are considered invalid and will not be accepted. PUMA Indonesia holds the sole discretion and rights to disqualify any invalid receipts.
